# **SPRING – BOARD GOVERNANCE RETREAT**

The Board Development Committee (BDC) is planning on hosting a Spring – Governance Retreat in April 2021. The agenda of the retreat will include an assessment of the outcomes of the Fall – Governance Retreat, a review of the CWC PCN Ends Policies and a generative discussion on the renewal process of the 2022-2025 Business Plan. The Board members, Joint Venture Governance Committee members and CWC PCN Leadership Team will be participating in the retreat.

## **BUSINESS PLAN AMENDMENT (BPA)**

The Board and Joint Venture Governance Committee approved a Business Plan Amendment (BPA) submission to allocate unexpended grant funding in the amount of \$250,000 from the 2019-2020 fiscal year towards the Calgary Zone Business Unit Zonal Service Plan, as all Calgary Zone PCNs are required to fund the Zone Service Plan. The BPA submission deadline to Alberta Health is February 26, 2021.

## AGM DEBRIEF

The Board reviewed the survey results from the 2020 Virtual Annual General Meeting (AGM) Evaluation. Overall, participants reported being satisfied with the format of the virtual AGM, although technical issues were identified as a challenge for some participants. The Governance & Policy and Member Services &

Engagement departments are working in conjunction to identify the most optimal virtual platforms for the 2021 AGM and for mechanisms to make the user experience easier for members.

## CALGARY ZONE PCN UPDATES

The Board congratulated AHS member, Dr. Mike Spady, for being selected as Doctor of the Week in the Zone by the Chief Medical Officer at AHS. Dr. Mike Spady has continually advocated for the value of primary care, in particular the patient medical home, and as such has been vital to the Calgary Zone's response to the COVID-19 pandemic
