

Privacy Impact Assessment

Any changes or proposed changes in an organization that will relate to the collection, use, or disclosure of individually identifying personal or health information requires the submission of a Privacy Impact Assessment (PIA). PIAs that provide sufficient detail on the proposed administrative practice and system and describe reasonable measures to protect information collected, used and disclosed are generally accepted by the Office of the Information and Privacy Commissioner (OIPC). The table below shows the submitted and accepted PIA of the Calgary West Central Primary Care Network (CWC PCN).

CWC PCN PIA overview	
OIPC file number	Description
H1306	The original CWC PCN PIA that covers administrative measures to protect the security and confidentiality of information; for example, stating the purpose of data collection and who will be responsible for safekeeping once collected.
H1717	For the expanded collection of physician membership information.
H4677	Covers the Evaluation and Quality Assurance Program started by the CWC PCN to better manage operational goals and contribute to a systematic culture of learning and improvement, which requires collection of patient and clinical data across the PCN.
H5021	For the Central Information Technology (IT) infrastructure project that provides the capability to handle the current and future IT needs of the CWC PCN. The program is co-located at DataHive, a secure facility that IT service provider can access and all data is protected in an appropriate manner.
H5122	Covers the process flow for clinic billing by the Primary Care Centre, Tsuut'ina Clinic and Senior's Health Services.
H4773	Submitted when the Westbrook Clinic (now the Primary Care Centre) was opened and the Wolf Electronic Medical Record (EMR) system and video surveillance introduced.
H5795	The Physician Office System Program (POSP) submission to the OIPC when it required a data migration by the Primary Care Centre. POSP was established by the Alberta Medical Association, Alberta Health and Wellness (now Alberta Health) and Alberta Health Services to promote the utilization of EMRs by physicians.
H4952	For the provision of information on Seniors Health Patient flow for Geriatric Assessment and Support and introduction of EMR remote access, updating PIA H4773.
H3125	Submitted because of the addition of the Tsuut'ina Clinic to the CWC PCN.
H4486	Amendment to PIA H3125 to cover the Tsuut'ina Clinic's use of Alberta Netcare Portal.

H6398	Amends PIA H4486 to include the Tsuut'ina Clinic's Telus Health Solutions EMR.
002758	Amends PIA H4677 due to the expansion of the Evaluation and Quality Assurance Program's services.
005386	Covers information relating to Seniors Health Patient flow for Geriatric Assessment and Support (GAS) and introduction of EMR Remote Access (updating H4773). Accepted April 18, 2017.
015853	OnCall Health Implementation, Patient Improvement Project, Tableau Software Analytic tool, HAP, CII. Accepted May 20, 2021 Dr. Rachel Han.
021190	CWC PCN PCC temporarily acts as a COVID-19 triage centre. Excel Health Family Practice and walk in clinic will temporarily manage patients who were referred to the PCC and allowing the PCC temporary access to excel health clinics EMR to enable the secure sharing of information.
021811	Endorsement – Community Information Integration (CII) Initiative and Central Patient Attachment Registry (CPAR – Privacy Impact Assessment. Accepted August 13, 2021, Dr. Judy Wong .
021813	Update, Calgary West Central Primary Care Centre – Privacy Impact Assessment. Accepted May 31, 2022, Dr. Judy Wong .
